## **Preserving Carson City History**

The history of Carson City is replete with wonderful stories about local places and people, such as the Capitol, the Carson Mint, the Nevada State Children's Home, the Nevada State Prison, the Chinese who lived and worked here, Carson City residents and Nevada founders who created and shaped Nevada history (such as Abraham Curry, William Stewart, Charles W. Friend, James Nye, Duane Bliss, Hannah Clapp, Judge Clark Guild, and many others), the impact of the Comstock Lode, the V&T Railroad, the Corbett-



Fitzsimmons fight, and on and on. We want the CCHS to tell these stories!

The arson fires at the Foreman-Roberts

House last year created an opportunity for the CCHS Board to rethink and clarify our organization's mission and collections policy. As we regretfully returned some of the contents of the house to their rightful owners (such as the Nevada State Museum) and moved the rest to the Carriage House for storage, the Board decided to align our collections policy more closely with our stated mission: "...to collect, preserve and present the history of Carson City for research and educational purposes for the public at large." To this end, we have researched collections policies of other historical societies, had a speaker come talk to the Board about collection

approaches, and subsequently decided to take a fresh approach to the Carson City Historical Society's future focus in the Foreman-Roberts House.

A committee has been formed of several Board members and interested members to review each of the items we have moved to the Carriage House to assess the "Carson City connection" of each item. Is it somehow connected to Carson City history? Where was it made? How did we acquire it? Would it help us tell a Carson City story? Items that do not seem to fit these guideline are being considered for sale or return to the original donor, if we have that information in our files. The items that we know fit our mission will be cataloged and marked and placed back into the house when it is ready. This group of volunteers has been hard at work over the summer, and we thank everyone for their time and commitment to this tedious but vital work!

If you see we have items for sale, know that each one has been carefully reviewed and assessed for its "fit" with the Historical Society's purpose. Thank you for your support of our efforts.
